The control bureau department of International Pets Transportation Inc wishes to inform you that .Your puppy will not be allowed transport to you because of the following, that needs immediate rectification:

REASON FOR GROUNDING YOUR PUPPY.

Following the EUROPEAN UNION Animal and Livestock Commission' Rules and Regulations on Animal Transportation, section 12 sub paragraph 2, "... the life of all animals being transported from or within the EUROPEAN UNION to another country must be fully Insured by an Insurance Co-operation against any eventuality.

Following a compromise between the EUROPEAN UNION Animal and Livestock Commission and the EUROPEAN UNION Financial Commission, it was concluded that "The life of all animals being transported from the EUROPEAN UNION to another Country OR city must be insured and this insurance fee would vary from one animal to another depending on Financial Value of the Animal."

We also wish to let you know that, according to the EUROPEAN UNION Price Determination Commission, the price of a puppy is estimated to 3500 euro to 5000 euro

- **Many jurisdictions around the world have enacted statutes which forbid **cruelty** to some **animals (PETS)** but these vary by country and in some cases by the use or practice.**

- In the AUSTRALIA AND NEW ZEALAND, cruelty to animals is a criminal offense and one may be fined or **jailed** for it for up to five years. On February 15, 1911, the House of Commons introduced the Protection of Animals act on behalf of the Royal Society for the Prevention of Cruelty to Animals (R.S.P.C.A.).
