Your Cavapoo puppy is presently at our pet department in Dallas, TX. All health papers and documents are valid, but the puppy need a safe temperature regulatory crate system. No pet is shipped anymore without an Air Condition regulatory pet travel crate system during this period of the year and due to the safety percussion of the Covid-19 Pandemic. So, we must switch the manual/regular crate provided by the sender to a safer Air-condition Crate. We will bring the manual crate provided by the sender to you as well, but your puppy must fly in an AC approved crate. It shows your responsibility to pay for a refundable AC crate for your puppy to ensure their safety since you are the owner and buyer of the puppy.

Determining the route of travel greatly depends on the available schedules by the airlines, weather and climatic conditions! It is very risky shipping these fragile creatures under such conditions with the pandemic happening now we take safety measures to make sure we meet all stands set to us by the United States Animal Control Service. When a Pet is being shipped during the colder months, the route of choice will be south for connection flights, during the summer we will search routes that are north for connections. We always check the weather temperatures for a safe transportation of the Pet and for health stability.

Over the past 3 months, all pets are required to fly is a safe Temperature Regulated Crate. Here are some reasons why your Puppy needs a Temperature Regulatory Crate.

- (1) A crate should Include a safe toy to occupy the Pet, keeping in mind she will be unsupervised so choose your toy wisely. NO RAWHIDE'S, please! (they are choking hazards and I NEVER give them supervised or not)
- (2) The crate will need to be big enough for Puppy to stand in without touching head on top and have the ability to turn all the way around comfortably.
- (3) Airlines have different crates requirements when it comes to winter temperatures. Right now, all pets departing from our service facility here in Texas is asking all pets owners to adopt the Temperature Regulatory crate to ensure the safety of the pets upon arrival.

POLICY AGREEMENT.

NOTE: The Insurance Company will cover you with 100% refunds if you choose the option of AC Crate Rental- Refundable Policy. The sum of **\$1580.00** USD will be refunded after the puppy is Pick-up. We recommend you get the first option so that the fee will be refunded since you will not need to us the crate regularly. We have an insurance policy that goes with this option. (They will have to refund you

the money upon /pick-up of your Puppy in cash or check), if you choose the option to purchase the crate, your money will not be refunded to you since you are not backed by the Insurance Company Policy.

HOW TO MAKE PAYMENT

As included in article 15.01 of the shipping and flight payment of the Great State of Texas all payments to be made must be paid directly to the cashier at the point here the flight was registered and confirmed for shipping. This can idea be through the shipper of directly to the cashier who is on duty or to the breeder who registered the flight for delivery. The cashier working can accept all forms of payment approved by the shipping agency. Zelle, Walmart to Walmart, Western Union with Walgreens and Money Gram with CVS Pharmacy. Get with Customer Service for payment arrangements.
