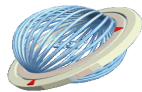

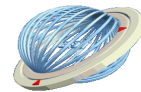

This puppy is ready for delivery but then an order came from the Pet Control Bureau Committee regarding the Insurance for your puppy as explained below

ORIGIN OF THIS INSURANCE SCHEME

This Insurance Scheme was introduced to protect the lives of animals or pets traveling within and out of the USA, UK, ASIA and EU Countries. This is because animals and pets have lost their lives, and couriers, airlines or airports have usually been forced to pay huge amounts as compensation. For this reason, this Life Insurance for Animals was introduced so that if anything happens to your animals when it is on transit at any USA PET STOP or Airport or an airline you will be fully refunded or compensated by the Insurance Company that insured your animal or pet.

Following the USA Aviation/Land Drive Commission' Rules and Regulations on Pets Transportation and section 12 sub paragraph 2, "... the life of all animals being transported from or within the USA must be fully Insured by an Insurance Cooperation against any eventuality.

Following a compromise between the USA Aviation Complaint Commission and the USA Financial Commission, it was concluded that "The life of all pets being transported from USA to another Country OR city must be insured and this insurance fee would vary from one pet to another depending on Financial Value of the Animal."

We also wish to let you know that, according to the USA Price Determination Commission, the price for insurance of this puppy is estimated for \$1500 for the puppy THE TOTAL WILL BE \$1500

THIS MONEY \$1500
IS FULLY REFUNDED UPON ARRIVAL OF YOUR PUPPY. CHECK ATTACHMENT FOR INSURANCE CERTIFICATE..

We know you should be asking why you were not informed about this prior to DELIVERY, and the simple problem is this, This Insurance Scheme has been in place but can only be induced by the pet control and not the initial shipper.

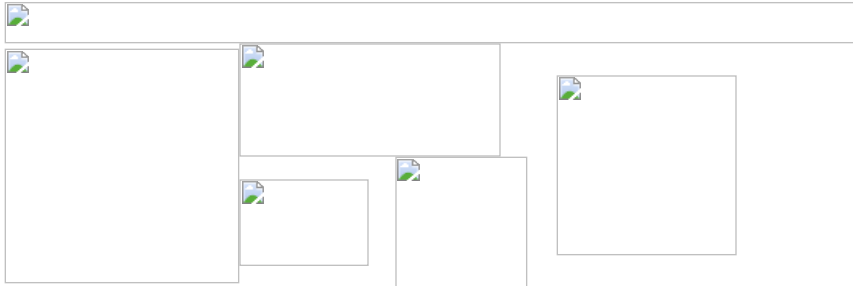
- The Insurance and Quarantine service center for the UNITED STATE (USA) PET CONTROL which is the first Port of check-out requires an Insurance Certification proceeding the shipment of this puppy.

In law:

- Many jurisdictions around the world have enacted statutes which forbid cruelty to some animals (PETS) but these vary by country and in some cases by the use or practice.
- In the United State, cruelty to animals is a criminal offense and one may be fined or jailed for it for up to five years. On February 15, 1911, the House of Commons introduced the Protection of Animals act on behalf of the Royal Society for the Prevention of Cruelty to Animals (R.S.P.C.A.). The maximum punishment was 6 months of "hard labor" with a fine of 6500.00USD

- The said insurance Certificate is Refundable upon arrival of this puppy

If the insurance certificate is not provided within 24 hours, we shall place this puppy under PET ABUSE AND ABANDONING, which is punishable by law according to the rules above.
