WARNING: This lawfirm does not currently exist in USA (as of May 2021). There once was a lawfirm by this name, but it closed shop.

Today, this lawfirm name is being used to commit a “financial recovery scam”, involving promises to recover from VXMarkets / VX Markets.

The website was created recently (February 2021,) and they are contacting targets with the traditional “recovery firm” script: (1) contact victims , , (2) claim to be able to recover, or have access to a way to

recover lost funds, (3) require the victim pay an advance fee and more fees.... and more fees. A tip: if the story was true, they would not need your “bond” – See e.g., <https://www.investopedia.com/articles/personal-finance/022916/dont-get-cheated-twice.asp#:~:text=Fake%20asset%20recovery%20firms%20solicit,who%20have%20already%20been%20victimized.>).

Scammers use a mix of truth and fiction. There once was a lawfirm by this name, but it was caught up in a malpractice action and shut down years ago. See e.g., <https://www.law360.com/articles/394587/fields-fehn-can-t-shake-malpractice-judgment> . The “lawyers” are impersonating current CA lawyers – here are tips to confirm this :

(1) anyone who claims to be a California attorney can be verified through the California state bar, and you can contact them at their registered contact information : <http://members.calbar.ca.gov/fal/LicenseeSearch/QuickSearch> . For example, the named partner (Sherwin) on their current website version is no longer in practice today: <http://members.calbar.ca.gov/fal/Licensee/Detail/69395>

(2) you can confirm California businesses with the California Secretary of State: <https://businesssearch.sos.ca.gov/> ; this lawfirm is not active today.

If you are contacted by “attorneys” saying they are from this lawfirm, to recover money for a fee? Hang up the phone/delete the email, and please report them to the Federal Trade Commission at www.FTC.gov, or the FBI at www.IC3.gov .
