Ferret Sales Contract

- 1. The Buyer shall provide the ferret with adequate food, fresh water at all times, shelter, affection, love, and medical care, including all necessary immunizations, parasite control, and medication recommended by Buyer's veterinarian.
- 2. The Buyer shall provide the ferret with veterinary care upon sickness, disease, or injury, and shall take it to a veterinarian at least once a year for an annual health examination and routine vaccinations.
- 3. The Buyer shall provide the ferret with humane care and maintain it in accordance with all current and future state, county, and municipal laws and ordinances where the Buyer resides.
- 4. The Buyer shall provide the ferret with space to play or other humane means of exercise. The ferret shall not be constantly kept in a cage.
- 5. The Buyer shall keep the ferret as a household pet and shall never use it for breeding.
- 6. The Buyer shall provide a collar and identification tag for the ferret to wear at all times when allowed to go outdoors.
- 7. The ferret shall reside at the Buyer's address.
- 8. If the ferret cannot be kept by the Buyer, the Buyer shall notify the Breeder immediately. The ferret shall not be sold, transferred, or given to any individual or to any retail or wholesale establishment for the purpose of sale or resale to the public, nor to any research institution where medical experimentation or other practices take place.
- 9. The Buyer agrees that the Breeder is in no way liable or responsible for any damage, accident, or injury resulting from the ferret.
- 10. The Buyer and Breeder agree to keep each other informed of their current addresses.
- 11. The Buyer agrees to pay the Breeder any and all expenses, including court costs and reasonable attorney fees, in enforcing the terms and provisions of the Contract.
- 12. Should the Buyer be unable or unwilling to fulfill any of the above provisions, the Buyer agrees to return the ferret to the Breeder at the Breeder's request and at the Buyer's expense. Should the Buyer refuse to return the ferret, the Buyer hereby authorizes the Breeder to pick up and remove the ferret from the Buyer's control.
- 13. In case of the unforeseen event of death within one year from its purchase date, or if the ferret is found to possess health disorders (within 1 year) which adversely affects

the health of the ferret, the Breeder will replace it with another ferret of equivalent value at no cost to the Buyer.
