Compliance

As well, you are expected to understand your obligations under Sanford Health policies. On an annual basis all employees and members of the Board are required to sign an Annual Acknowledgement of Corporate Policies form. Those of us who fail to abide by the Code and Sanford Health policies will be subject to disciplinary action, up to and including dismissal or prosecution.

Every effort should be made to protect Sanford Health working equipment and associated software from various threats to their security such as accidental or deliberate destruction of data or equipment, interruption of service, disclosure of confidential information, theft or corruption of data. Any security concerns with respect to our systems or software, or any viruses or data network attacks, weaknesses or unexplained system changes should immediately be reported to the HR. Our affiliated vendors will have them fixed as soon as possible.
