#### W-2 or 1099-MISC

We will send a W-2 form to our contractors or 1099-MISC form to non-employees who were paid \$600 or more during calendar year.

All 1099 forms, including Form 1099-MISC, must be filed with the IRS by January 31 for the previous calendar year. All W-2 are also due to contract workers by January 31 each year for the previous calendar year. For example, 1099-MISC forms for 2022 must be filed with the IRS and given to recipients by January 31, 2023.

Form 1099-MISC includes information on compensation paid the previous calendar year to various individuals and entities.
