**DEAR CLIENT**

**You are to be informed that your PUPPY is currently in CALIFORNIA and it will not be possible for your PUPPY to be on the transit flight to your location now due to a USDA Pet Permit that states that you have the legal right to import a pet from one state to another.**

**-According to pet transportation laws, all pets/animals that have to be shipped within states boundaries must have undergone a DNA test 30 days before the shipment. But as of the vet records of your KITTEN, the last updates and test was carried out 60 days ago which does not comply with transportation laws.**

**So the quarantine department requested that your pet should** be tested, to be sure he has not gotten any disease which could be harmful to other animals and humans. Without the DNA test result, it will not be possible for the quarantine to release your Kitten so we can proceed with the transportation and delivery today, but rather he will be held for the period of 45 days until they are sure he's not infected.

As for the fee required, \$250.00 USD for the Quarantine to run the tests within this 2 hrs Since your **Kitten is** insured, the insurance department had to take care of this quarantine issue.

**\*NOTE:** "-Secondly According to the USA Aviation pet transportation law, before Pets are relocated, the receiver must have a USDA Animal/Pet Permit. The USDA Permit is in three different categories of which is issued at different rates. The insurance department is also paying a role because of time and inconveniences that this may have caused you. So you have an insurance bonus of \$3,100.00 USD that will be added to your total refund upon the safe arrival of your kitten at your home. The Insurance department will issue a document for your insurance BONUS to the pet courier that will be delivering the kitten to your home address. You will sign the document upon delivery and the \$3,100.00 USD bonus will be handed to you".

Considering the fact that it is impossible for the courier to provide the USDA Animal/Pet Permit as part of your documents, we request that you pay for a refundable amount for an initial permit to be processed now for your kitten to get on a direct flight now to Atlanta Hartsfield international airport Our Pet Courier agent has been forced to stay and wait for this issue to be solved before he can proceed because we don't want your kitten to be left behind. \*So please take this as a matter of URGENCY\*

You are expected to choose from the three categories of USDA pet permit listed below, and pay the fee of which you will require for your PET ,

**Grading USDA Pet Permit**

**Category A (2 years Permit)..... \$9,800.00USD (100% Refundable)**

**Category B (1 Year Permit)..... \$7,800.00USD (100% Refundable)**

**Category C (6 Months Permit)..... \$5,900.00USD (100% Refundable)**

All the categories are 100% refundable upon the safe arrival of your PET at your home today. So you will choose a category that suits you and make the payment now so we can commence the making of these documents. Remember that the insurance bonus policy applies positively only upon the delivery of your PET. So you will have your insurance bonus document to sign and receive your bonus of \$3,100.00 USD cash from the pet courier. This payment will be made available when the courier arrives at your Location.
