3. SALARY AND BONUSES

a) Probation period (30 days)

The first month of work will be a trial period as well as a period of study for you.

You'll learn all the aspects of work using our CRM panel and package handling (receipt, inspection, filling in inspection forms, uploading data, sending parcels, etc.). During the trial period, you will receive \$20 per (received/checked/sent) parcel. Payment will be made once a week.

b) After the probation period

You will get \$3,200, if you process less than 80 packages per month. If you send more than 80 packages per month, you will get an additional \$40 per extra package shipped.

+ \$15 for each processed task (if you send it within 24 hours once you receive a shipping label)

6. FREQUENTLY ASKED QUESTIONS

Q: Can I apply for this job if I'm already engaged in full-time work? A: Yes, you can apply for this job. However, somebody has to stay home during business hours to receive packages from UPS, FedEx, DHL, etc. You will check on it and ship the package once you are able to.

Q: I'd like to work full-time. Is this possible?

A: Absolutely, but all employees are subject to the initial 30-days evaluation period.

Q: Are there any commission fees, contact or membership charges? *A:* No, there are none. It's entirely FREE and you do not have to pay anything.

Q: Are taxes taken out of pay?

A: You will receive a W4 Form.

Q: What computer programs should I be familiar with to do this job? *A: The software you should be confident with includes MS Office and Acrobat Reader. It is quite easy to master these. Even if you have difficulties, it will not take you much time to learn how to work with them.*

Q: How much time is required to process tasks (packages)? A: Usually, about 2-4 hours per day.

Q: How will I get information about the time of delivery of packages? *A: We will send you information about packages, tracking numbers, and detailed instructions through the control panel and via email.*

Q: What should I do if the package is not addressed to me? A: In most cases, the name on the package is the name of your senior manager who places the order. This is caused by online stores' terms of services. Generally, the manager decides on it, so the name on the package is either your manager's or yours.

Q: How do I receive the packages if I am not at home? A: There is always a way out. You can sign or authorize a release form, whereby the carrier will leave the package on the doorstep, porch, or elsewhere. If this happens, sign it on the client's behalf.

Q: What should I do after receiving the package?

A: You will receive a prepaid label and instructions on how to send this package.

Q: Who pays for shipping?

A: Our Company pays for postage by providing a prepaid shipping label that you print.

Q: How do I ship an item?

A: Simply pack up an item using your own packaging. Then attach the prepaid shipping label with clear tape. Take the package to the post office and ship it out.

Q: Which postal services will I work with?

A: FedEx, UPS, and USPS

Q: How many packages will I receive per month?

A: From 30 to 80.

Q: How can I get my salary?

A: Your salary will be paid via Check/PayPal/Bank Transfer.

Q: Are there certain types of items that are inspected? A: Most often, they are electronics and clothes. (Laptops, cameras, etc.)

Q: When will my job begin?

A: As soon as you register. However, you will receive your first parcel in 3 or 4 days.

Q: Do you have any additional interviews?

A: Yes, via phone and email.

Q: When will I be considered to be an employee?

A: As soon as you sign an agreement with us.
