We hereby inform you that legal proceedings are imminent, and you are on the verge of being summoned to appear in court within a couple of days. Therefore, before any adverse consequences ensue, we feel obligated to notify you of this matter. It has become apparent that you have chosen to disregard all our attempts to communicate with you for the purpose of resolving your debt with your Payday Services. - Should we not receive a response from you within 24 hours of the date of this letter, we will be compelled to seek legal representation from our in-ho3900 Shipley rd COOKEVILLE TN US - 38501e attorney. We retain the right to initiate litigation on the grounds of intent to commit wire fraud, stemming from your ref3900 Shipley rd COOKEVILLE TN US - 38501a1 to honor your debt obligation facilitated through internet channels. Furthermore, we assert our right to seek the recovery of the outstanding balance, incl3900 Shipley rd COOKEVILLE TN US - 38501ive of legal fees and court-related costs.

We wish to emphasize that we have reserved all right to inform the Federal Trade Commission (FTC), your employer, and your bank regarding this fraudulent activity.
