FREELANCE ILLUSTRATION AGREEMENT

1. Scope of Work

The Artist agrees to create four (4) original, fully rendered illustrations in accordance with the creative direction provided by the Client. These illustrations are intended for use in connection with an educational workshop targeted at a teen audience.

Each illustration will meet the following specifications:

- Fully rendered, high-resolution
- Sized and formatted for print at 8.5 x 11 inches
- Delivered as flattened, print-ready PNG or PDF files
- Delivered with the original source files in Photoshop (PSD) files.

2. Timeline

The Artist agrees to deliver the final illustrations on or before August 18, 2025, with a mutually agreed-upon delivery schedule for drafts and revisions within the 14-week timeline.

Proposed milestone delivery:

- Concept Sketches (All four illustrations): Within 7–10 days of receiving the initial payment.
- Phase One Illustrations: Within 5–7 weeks after sketch approval.
- -Phase One Final Delivery: Within 24 hours of client's written confirmation of satisfaction with the Phase One illustrations.
- Phase Two Illustrations: Within 5–7 weeks after Phase One's Final Delivery.
- -Phase Two Final Delivery: Within 24 hours of client's written confirmation of satisfaction with the Phase Two illustrations.

3. Revisions

The project includes up to two (2) rounds of revisions per illustration. Additional revisions outside the scope will be billed at [\$35/hr].

4. Payment Terms

The Client agrees to pay the Artist \$2000 per illustration, totaling \$8000 for four illustrations.

- 50% deposit due upon contract signing: \$4000
- 50% balance due upon final delivery of all files: \$4000

Payment is accepted via Cashier's Check/Bank Certified Check or PayPal. Late payments beyond 14 days may incur a late fee of 5%.

5. Licensing & Rights

Upon receipt of full payment, the Artist grants the Client the following rights:

- Exclusive, perpetual rights to use the illustrations for educational purposes, including but not limited to print materials, workshop presentations, and internal communications.

- The Client may not resell, license, or sublicense the artwork to third parties without written consent from the Artist.
- The Artist retains moral rights and may display the work in their portfolio and social media, unless the Client requests confidentiality in writing.

6. Ownership of Original Files

The Artist will deliver flattened print-ready files (PNG or PDF) and Editable files (e.g., PSD, layered files)

7. Cancellation Clause

If the project is canceled by the Client after work has begun, the Artist retains the deposit and will be compensated for any work completed to date.

8. Indemnification

The Client agrees to indemnify and hold harmless the Artist from any and all claims, liabilities, damages, or expenses arising out of the use of the final illustrations, provided the use is consistent with the agreed-upon purpose.
