Dear Officer Swanson,

I am writing to provide additional information and documentation regarding my case involving unauthorized use of my identity, harassment, and ongoing online activity that is affecting my safety and reputation.

My name is Brenda Izzo, and I am the owner of Mobile Massage by Brenda in Fort Lauderdale, Florida. I am a massage therapist, nail technician, and esthetician. My services are strictly professional and non-erotic. I did not authorize, create, or consent to any content posted about me on harloithub.com or any similar websites.

Below is a clear timeline showing when my ads were posted by me on Craigslist and when they were stolen and reposted on harloithub.com:

- **August 13, 2024** – **Unauthorized** listing posted on **Harloithub** (Listing ID: **9158653524**). This appears to have been taken from my **Google business information** using my previous phone number (**754-204-3218**).
- **March 11, 2026** – **Unauthorized** listing posted on **Harloithub** (Listing ID: **9159342398**). **My Craigslist** ad was posted by me the **Same Day** and then copied.
- **March 16, 2026** – **Unauthorized** listing posted on **Harloithub** (Listing ID: **9159349439**). This content was taken from my **Craigslist** ad that I posted on **March 14, 2026**.
- **March 20, 2026** – **Unauthorized** listing posted on **Harloithub** (Listing ID: **9159353046**). This content was taken from my **Craigslist** ad that I posted on **March 19, 2026**.
- **March 23, 2026** – **Unauthorized** listing posted on **Harloithub** (Listing ID: **9159356354**). This content was taken from my **Craigslist** ad that I posted the same day.
- **April 4, 2026** – **Unauthorized** listing posted on **Harloithub** (Listing ID: **9159368454**). This content was taken from my **Craigslist** ad that I posted on **March 26, 2026**.
- **April 6, 2026** – **Unauthorized** listing posted on **Harloithub** (Listing ID: **9159370413**). This content was again taken **March 26, 2026** from my **Craigslist** ad.
- **April 8, 2026** – **Unauthorized** listing posted on **Harloithub** (Listing ID: **9159373297**). This content was taken from my **Craigslist** ad that I posted on **April 7, 2026**.
- **April 10, 2026** – **Unauthorized** listing posted on **Harloithub** (Listing ID: **9159375370**). This content was taken from my **Craigslist** ad that I posted on **April 9, 2026**.

This shows a clear pattern that starting on March 11, 2026, my Craigslist advertisements were being monitored, copied, and reposted without my permission shortly after I posted them.

On March 6, 2026, I received threatening text messages from a phone number (954) 526-8091 from an individual requesting sexual services. I refused, and the individual sent multiple threatening messages. A search of this phone number showed a name associated with it as Joshua Richstone. I do not know if this individual is directly responsible for the unauthorized postings, but the timing of these threats and the start of the online activity is concerning.

Since that time, I have experienced ongoing harassment including explicit messages, nude images, repeated phone calls from private numbers, and unsolicited WhatsApp video calls.

On April 6, 2026, a man was driving around my street, which is a dead-end road, and blocked my car while I was getting into my car. He asked me where the Fort Lauderdale Police Department was located and also asked where a bath house was. This situation made me feel unsafe and concerned.

On April 13, 2026, I discovered that my information and advertisements were posted on harloithub.com without my consent. I was horrified. That same day, I immediately removed all of my Craigslist advertisements for my safety.

I have attempted to contact harloithub.com multiple times through their website requesting that these unauthorized listings be removed, but I have not received any response.

After this occurred, I searched my phone number online and discovered that my personal information, including a previous residential address, was publicly associated with my phone number. I have since contacted Google to request removal of this information. This exposure has never happened before and I believe it is connected to my information being posted on escort-related websites without my consent.

I am a newly licensed Property and Casualty insurance agent, and I believe this situation has negatively impacted my ability to obtain employment. I am absolutely embarrassed and horrified that my name and information have been associated with this type of content.

I have preserved all evidence including screenshots, call logs, copies of the unauthorized postings, and my attempts to contact harloithub.com, and I am prepared to provide them.

I have reported this matter to the Federal Trade Commission and the FBI's Internet Crime Complaint Center (IC3), and I am continuing to report it to the appropriate authorities.

I respectfully request that this information be added to my case file and that any guidance or assistance be provided to help protect my safety and stop this ongoing activity.

Thank you, Officer Swanson, for being so kind and for making me feel comfortable during this process. I truly appreciate your help.
