Dear Officer Swanson,

I am providing additional information to clarify the timeline in my case and to support the ongoing investigation.

I was trying to understand why the unauthorized postings of my ads on Harloithub began on March 11, 2026 and not earlier. I have determined the reason based on the following timeline.

On March 6, 2026, I posted a Craigslist ad at 1:31 PM. That same ad was flagged and removed on March 6, 2026 at approximately 6:22 PM. At 6:22 PM, I sent an email to Craigslist explaining that I believed my ad was flagged due to a person who had been threatening me earlier that day.

On March 6, 2026, between 4:38 PM and 5:15 PM, I received threatening text messages from the phone number (954) 526-8091, which is associated with the name Joshua Richstone. I included this phone number in my complaint to Craigslist.

My next Craigslist ad was posted on March 11, 2026 at 11:41 AM. This is the same date that my ads first began being copied and reposted on Harloithub without my consent.

This establishes a clear timeline showing that the unauthorized reposting activity began only when my ads became active again.

Below are the dates and times I posted my Craigslist advertisements:

- March 11, 2026 – 11:41 AM
- March 14, 2026 – 9:58 AM
- March 19, 2026 – 11:04 AM
- March 23, 2026 – 11:07 AM
- March 26, 2026 – 9:52 AM
- April 7, 2026 – 8:33 AM
- April 9, 2026 – 8:25 AM
- April 11, 2026 – 9:11 AM
- April 13, 2026 – 9:34 AM

These dates directly correspond with when my ads were later copied and reposted without my consent.

In addition, I went on lookup.icann.org. went on register and put harloithub.com

I'll put all that information down below.

On **Friday, April 17, 2026** at approximately **6:32 PM**, I sent an email to ***abuse@internet.bs regarding the harloithub.com domain.***

The response I received stated the following:

“Thank you for contacting us. Your request (4163364) has been received and is being reviewed by our support staff.

If you need to add additional comments, please reply to this email.

Hello Craigslist Team,

My name is Brenda Izzo. On **Friday, March 6, 2026**, I was harassed by a man via text from **4:38 PM to 5:15 PM**. I am sending this email because I am concerned he may try to flag my ad, and I want to alert Craigslist about what happened.

I do not know his name, but his phone number is **(954) 526-8091**.

The messages began with him calling me “gorgeous” and asking if I had “menu options not listed to create the perfect end.” When I asked for clarification, he continued with: “Do you have options for the ending of the massage or during it? I am more interested in a body rub to relieve stress. The kind only a woman can give a man.”

I responded that this was **absolutely not acceptable** and called him **disgusting**. I made it clear I would **not provide any sexual services** and told him **not to contact me**. Despite this, he continued to send aggressive messages and said I had been “officially warned.”

I am concerned that this individual may try to flag my ad maliciously. If you come across this number on your platform, I would appreciate it if you could take appropriate action.
